1.0 **PURPOSE**:

- 1.1 To ensure IP&C Manuals are followed in WRHA facilities, programs and funded sites.
- 1.2 To ensure compliance with Accreditation Canada Required Organizational Practice (ROP) Standards (4.2) requiring the organization maintain IP&C policies and procedures based on applicable regulations, evidence and best practices, and organizational priorities.
- 1.3 To ensure a process is in place for approval and revision of contents of the IP&C Manuals.

2.0 **DEFINITIONS**:

- 2.1 <u>Best Practice Documents:</u> Documents supported by objective and comprehensive research and evaluation, and subjective and objective data sources.
- 2.2 <u>Infection Prevention & Control (IP&C) Manual:</u> There are 3 manuals; acute, community, and personal care homes/long term care. These manuals are developed by IP&C and contain policies, operational directives, protocols, and best practice documents that, when applied consistently in health care settings, can prevent or reduce the risk of transmission of microorganisms to health care providers, clients/patients/residents and visitors. The process for approval of content in each IP&C Manual is outlined in the manual and can be accessed below at 3.4.1-3.4.3.
- 2.3 <u>Operational Directives:</u> Documents which establish the direction of how a process or procedure shall be followed according to evidence based standards and guidelines.
- 2.4 <u>Required Organizational Practice (ROP):</u> Evidence-based practices established by Accreditation Canada that mitigate risk and contribute to improving the quality and safety of health services.
- 2.5 <u>Staff:</u> All persons employed by the WRHA facilities or WRHA funded facilities, as well as members of the medical staff, volunteers, board members, students and others associated through contracts.

- 3.2 The IP&C Program shall develop, revise and maintain IP&C Manuals to address IP&C related issues in consultation with regional stakeholders.
 - The management of the manuals shall be the responsibility of the site/facility/program. This includes updating when revisions have occurred, location of the manuals (where hard copies still exist), and training if required.
- 3.3 IP&C Manuals shall be easily accessible to all staff.
- 3.4 The process for approval of content in each IP&C Manual shall be outlined in the manual.
