
A provincial comparison of per capita costs for government health care sector expenditures. Actual and age-sex standardized costs are provided for four years.



## **Highlights:**

- In 1998, government health care expenditures in Manitoba were \$1,848 per capita. This was reduced to \$1,747 after standardizing for age and gender. Compared to the three other western provinces, Manitoba's per capita rate ranked 2<sup>nd</sup> highest in the actual and 3<sup>rd</sup> highest in the standardized figures in 1998. The Manitoba standardized rate was \$45 per capita less than the Canadian rate.
- In 2001, Manitoba's per capita rate increased to \$2,431 actual and \$2,330 standardized per capita cost. Compared to the three other western provinces, Manitoba's per capita rate ranked 2<sup>nd</sup> highest in the actual and 3<sup>rd</sup> highest in the standardized figures in 2001. Manitoba standardized rate was \$143 per capita more than the Canadian rate.
