Aboriginal Population Projections

CHA REPORT 2004

Definition/Description:

A population projection is defined as "a prediction of population growth or decline based on historical demographic trends using mathematical modelling and the assumption that current or predicted trends do not change significantly."

Projected Aboriginal Population, for the City of Winnipeg to 2016.

For the purposes of this series of projections, categories 'Aboriginal population' were defined as follows:

<u>Status Indian</u>: A person who declared being a Registered Indian irrespective of his/her Aboriginal ancestry. Also included in this category is Inuit people. **Inuit**: A non-registered Indian who indicated an Inuit ancestry irrespective his/her Aboriginal ancestry;

<u>Metis</u>: A non-registered Indian and non-Inuit individual who indicated a Metis ancestry; <u>Non-Status or Other</u>: The Non-Status and Other Indian category is the residual category and includes individuals who are not registered and whose only Aboriginal ancestry is North American Indian.

Notes: These projections were developed using 1991 Census data as the base.

Highlights:

- Although the data is somewhat dated, it is included to illustrate the expected trends relative to changes in the Aboriginal populations for Winnipeg as defined above.
- A portion of the changes observed in 'Status Indian' and 'Non-Status and Other Indians' are as
 a result of the number of individuals who regained 'status' under Bill C31. In 1997, it was
 expected that 93% of the persons regaining 'status' would originate from the 'Non-Status and
 Other Indians' Aboriginal category.
- The 'Status Indian' category was projected to grow by 83.2% between 1991 and 2016 with an average annual growth rate of 2.5%.
- The 'Metis' category was projected to grow by 49.5% between 1991 and 2016, with an average growth rate of 1.6%.
- The 'Non-Status and Other Indians' category was projected to decrease from 15 000 in 1991 to 11 000 in 2002 before increasing to 12 500 by 2016. This is a result of Bill C31 as noted above.
- Substantial increases in the overall Aboriginal population are expected. As a result, the Aboriginal population in the WHR will represent an increasingly large proportion of the total population.
