

**Winnipeg Regional Health Authority (WRHA) and Health Sciences Centre (HSC)- Shared Health (SH)
Acute Care ADULT Code Blue Education Plan**

GOALS and OBJECTIVES:

- Provide all clinical Staff in acute care facilities with the educational plan and skills required for optimizing patient care outcomes during Code Blue events.
- The Code Blue Team, as defined in the WRHA/HSC (SH) Code Blue Team Resuscitation in Acute Care ADULT policy, shall practice, and demonstrate competence within their assigned role(s) during Code Blue events.
- Foster a culture of continuous improvement that supports staff, patients, and families before, during and after Code Blue events.

EDUCATION PLAN:

- **Code Blue Response Training for all staff is specific to their work area(s) and role(s) within the health care team**, as outlined in the WRHA Code Blue Response Training policy/HSC (SH) Cardiopulmonary Resuscitation Training policy.
 - The Code Blue Team shall have annual Basic Life Support (BLS) certification as determined by their Facility/Unit.
 - The Code Blue Team Physician/delegate, Registered Nurses (RN) and Registered Respiratory Therapist (RRT) shall be familiar with current Advanced Cardiovascular Life Support (ACLS).
- **Clinical educators shall provide all Employees with Code Blue training that is specific to their work-area(s) and role(s) during Code Blue events** as per WRHA Code Blue Response Training policy/HSC (SH) Cardiopulmonary Resuscitation Training policy.
 - Code Blue education occurs on hire and every 1-2 years, and may consist of some of the following:
 - Annual BLS certification in accordance with the WRHA Code Blue Response Training policy/HSC (SH) Cardiopulmonary Resuscitation Training Policy
 - Compression Clinics
 - Mock Code Blue sessions
 - Cardiopulmonary Resuscitation (CPR) feedback device(s) shall be utilized for CPR, BLS, and ACLS education.
 - Teaching strategies may include a variety of instructional methods/techniques including self-directed learning and/or simulation activities such as mock training sessions which promotes closed-loop communication between interdisciplinary team members and the practice of compression skills.
 - Clinical Educators maintain records of staff code blue education/training.
- **Code Blue Education for ALL Clinical Staff** - may include, but is not limited to the following:
 - WRHA/HSC (SH) Code Blue Team Resuscitation in Acute Care ADULT Policy (110.050.010), WRHA Code Blue Response Training policy/HSC (SH) Cardiopulmonary Resuscitation Training policy;

- Facility/Unit specific Code Blue procedures and processes, including but not limited to:
 - activating Code Blue response;
 - locating and maintain emergency resuscitation equipment,
 - Orientation to the geographic environment/work area(s);
 - Orientation to roles/tasks during a Code Blue event specific to the staff role in the health care team;
 - Current BLS practices and/or certification, as applicable to the Facility/Unit and role within the health care team and Code Blue events;
 - Recognition of clinical signs and symptoms of deterioration and identify appropriate escalations or interventions;
 - Operating an Automated External Defibrillator (AED), specific to Facility/Unit;
 - Communication strategies during Code Blue event and at handoff:
 - Communicate patient status and pertinent history to the multidisciplinary Code Blue Team upon their arrival;
 - Close loop communication strategies during the code event;
 - Patient handover report when transfer of care required;
 - Additional tasks to assist the Code Blue Team, such as compressions, clearing of patient environment, or accessing unit specific equipment/supplies, if applicable during a Code Blue event;
 - Documentation of assessment and interventions on the WRHA/HSC (SH) Code Blue Resuscitation Record as applicable to staff role in the health care team, and review of documentation with the Code Blue Team;
 - Communication and support of the patient families during resuscitation and promotion family presence.
 - Promotion and participation in Post Code Blue events such as a Review, Debrief, or “The Pause” when applicable.
 - Completion of Code Blue Review Forms following a Code Blue event.
- **Code Blue Education for Code Blue Team Members** - in addition to above, may include, but is not limited to the following:
 - Designated areas of responsibility within a Facility, including response routes and specific processes for elevator access/override;
 - Location and maintenance of standardized Code Blue Carts (as identified by WRHA and HSC (SH) Code Blue Team Resuscitation in Acute Care ADULT policy);
 - ACLS algorithms familiarization and adherence
 - Facility/Program/Unit specific processes and protocols related to Code Blue and specific patient related factors;
 - Communicate with unit Clinical Staff/Direct Care Providers when assuming care of the patient during a Code Blue event;
 - Transporting patients as required, post Code Blue event;
 - WRHA/HSC (SH) Code Blue Resuscitation Record documentation review for completion and accuracy
 - Leading/Initiating in post Code Blue events such as a Review, Debrief, or “The Pause” when applicable.
- **Code Blue Education for Physician as Team Medical Leaders who Respond to Code Blue Events** - may include the following, but not limited to:
 - Code Blue Simulation Education:

- Self-directed Continuing Medical Education (CME) learning activities such as ACLS training/updates;
- Facility/Unit procedures, processes and protocols related to Code Blue
- **Code Blue Education Specific to Managers and/or Program Designates Participating in Code Blue Reviews:**
 - WRHA/HSC (SH) Code Blue Resuscitation Records and Review forms;
 - Collection of data to facilitate staff education and quality improvement activities;
 - Communication with site Code Blue Improvement Group on Code Blue practice issues/concerns identified from Code Blue Review forms and collaborate on site Code Blue strategies.

* For the purpose of this education plan Staff as defined by the WRHA/HSC (SH) Code Blue Team Resuscitation in Acute Care ADULT policy are employees and medical Staff of the WRHA and HSC (SH) working in acute care facilities. Students working in a clinical area may be involved in a Code Blue and follow policies that govern their practice.
